About the event

The Faculty of Law and Administrative Sciences at the Ovidius University of Constanța is pleased to announce the 6th International Student Conference, which will take place on 8 May 2026 in hybrid format: in-person (Campus Building A, 1 Alea Universității, Constanța) and online.

The conference aims to promote academic research, critical thinking, and persuasive argumentation, essential skills for future professionals in the fields of law and administrative sciences. By combining scientific inquiry with public speaking, the event provides students with the opportunity to present their research, exchange ideas, and engage in scholarly debate within a multilingual and multicultural academic environment.

The conference follows a competitive format, encouraging academic excellence and creativity. The best presentations in each section will be awarded at the end of the conference.

Eligibility

The conference is open to students enrolled in bachelor's or master's degree programmes in law or administrative sciences at accredited universities in Romania or abroad.

Thematic areas

Participants are invited to submit papers addressing topics related to law and administrative sciences, including but not limited to:

- **Criminal Sciences** (e.g. *Criminal Law, Criminal Procedure, International Criminal Law, Humanitarian Law*)
- **Private Law** (e.g. *Civil Law, Family Law, Business Law, Private International Law, Civil Procedure, ADR*)
- **Public Law** (e.g. *Constitutional Law, Administrative Law, EU Law, Environmental Law*)
- **Administrative Sciences** (e.g. *Public Administration, Urban Planning, Public Procurement*)

Submission guidelines

Participants are required to submit the following information during registration:

- Title of the paper
- Abstract (200–300 words)
- 3–5 keywords

Abstracts will be evaluated through a peer-review process conducted by the conference's scientific committee. Notification of acceptance will be sent to the email address provided during registration.

Presentation format

Each presentation should not exceed 10 minutes. Participants may use PowerPoint slides to support their presentations. Depending on the topics of the accepted papers, the organizers may group presentations into thematic panels, followed by discussion sessions or Q&A segments.

Participants may present either in person or online.

- Notification of acceptance: 1 May 2026, via e-mail
- Conference date: 8 May 2026
